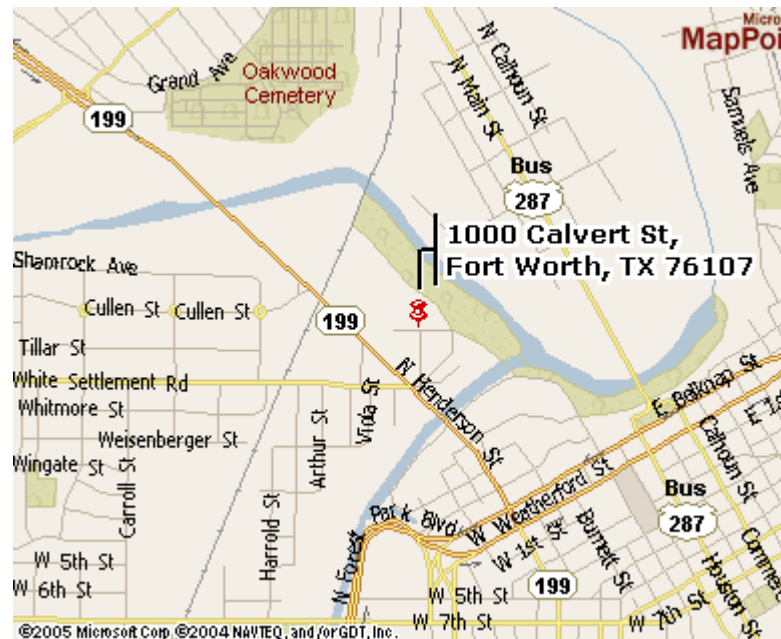
FORT WORTH hosts APRIL 2005 CPAANT MEETING
