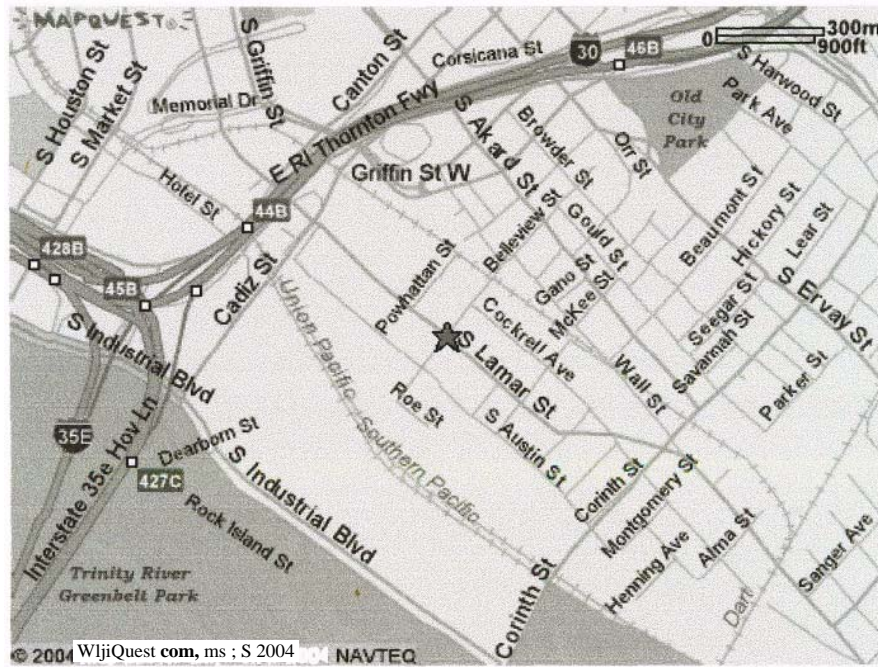

**DIRECTIONS** (picture from [www.mapquest.com](http://www.mapquest.com), directions from [www.mapblast.com](http://www.mapblast.com)):

**Heading northbound on 1-35 (coming from the south):**

1. Take 1-35 northbound
2. At exit 428B, turn RIGHT onto the ramp toward 1-30 / Texarkana
3. Stay on the RIGHT to stay on the ramp toward Lamar St/ Griffin St
4. This turns into RL Thornton Fwy
5. Keep LEFT onto ramp towards Lamar St
6. Turn LEFT onto South Lamar St, go until you reach 1400 S Lamar St

**Heading southbound on 1-35 (coming from the north):**

1. Take 1-35 southbound, merge onto 1-30 EAST via exit 428A on the LEFT, toward Texarkana
2. Turn RIGHT onto the ramp toward Lamar St/Griffin St
3. This turns into RL Thornton Fwy
4. Keep LEFT on the ramp toward Lamar
5. Turn LEFT onto S Lamar St, go until you reach 1400 S Lamar St

**Park either behind the building or across the street, parking should be free on Saturday. Go through the front doors, past the front desk security guard, go up the stairs, and the second floor media room is at the top of the stairs. See you there on Saturday, February 4, 2006!**
